Room stuffing: if we do not curb room stuffing, the hotels will raise the rates to over \$200 a night. One hotel will not sign a contract with Sakura-Con again due to the room stuffing issue. PLEASE DO NOT PUT MORE THAN FOUR PEOPLE IN A ROOM PER NIGHT!

We are working on special perks for people who rent rooms. If you have an idea, please let the exec board know.

# **Secretary**

Needs to put together an updated staff position structure

Staff bloat was a problem last year. In order for this to be curbed, more stringent requirements are being required of staff. This will be accompanied by a commensurate increase in benefits. To track this, Directors, Coordinators, and Managers are being asked to CC the <u>Secretary@sakuracon.org</u> with any staff changes, whether that's adding staff, releasing staff, or transferring staff. In addition, make sure your staff members are pre-registered! Remember: there is no such thing as walk-up staff.

Also looking at gathering metrics for communications. While you don't have to CC the Secretary on every piece of communication that occurs between staff members, please have a general estimate of whom you talk to and how often. A communications survey will be making the rounds of all Directors, Coordinators, and Managers each quarter.
